

Dear Dillon Valley Owners,

At our annual Dillon Valley East meeting in September, parking concerns emerged as one of the top priorities for our community. Many residents expressed frustration about limited parking availability, unauthorized vehicles occupying spaces, and the lack of clear enforcement procedures. After careful consideration and input from homeowners, the Board has developed a comprehensive parking management system designed to ensure fair and equitable access for all residents.

**Effective January 1, 2026, all owners will be required to submit a signed parking agreement, and all vehicles parked at Dillon Valley East will be required to display valid parking permits.** This new system will help us identify authorized vehicles, prevent unauthorized parking, and maintain order in our community lots.

**What You Need to Do:** Each unit will receive two parking tags upon submission of their signed parking agreement. These tags must be visible on any vehicle when parked in DVE lots. As a reminder, Section 4.10 of the Declarations allows use of only two parking spaces per unit. If you require additional temporary tags for guests or visitors, please contact the clubhouse to discuss available options.

If owners cannot come in person to pick up their parking passes, they must submit written authorization identifying who has authority to pick up their passes.
